





## WHAT'S INCLUDED IN THE TRIP TO CANCUN:

- Lodging: Includes 3 days and 2 nights in the hotel headquarters in Cancun, soon to be published.
- Expenses Included: All expenses related to food and lodging are included during the contest stay.
- Take a Guest: You have the possibility of taking a guest if you meet the goals set out in the scoring tables at the end of this document.
- Trip Date: May 2020, the date will be published soon.

## **CONTEST RULES:**

- **1.** Ardyss Distributor: You must be registered as an ArdyssLife Distributor or Brand Partner and be active in the company.
- **2.** Register for the trip: It is mandatory that you are registered for the Trip to Cancun, otherwise you will not be able to attend and you will not receive follow-up in your goals and progress. You can register in the following ways:
  - **a.** Through the website: cancun.ardysslife.com.
  - **b.** Through your country's call center
  - **c.** In your Back Office inside the Dashboard, section International Trip.
- **3.** Contest and travel dates: Contest period begins October 2019 and ends March 2020. The trip date will be May 2020; the exact date will be published soon.
- **4**. Goals through "Trip Points": Trip Points are composed of the sum of your Personal Points (PQP) plus the Personal Points only of the members you enrolled in your team regardless of their placement. Trip Points are not related to GQP Group Qualification Points, this contest will focus exclusively on your production and that of your enrollees. If you enroll new people in your organization month by month, those points will count towards your Trip Points.
- **5.** Maximum 500 points per Distributor: Your Trip Points are the sum of your Personal Points (PQP) plus the personal points of your enrollees. The maximum that will be considered in both your own ID and the ID of your enrollees will be 500 points. Consider this to have enough people doing their purchases in order to reach your goals.
- **6.** Meet 100% in each month: You must meet your goals in Trip Points in each of the months so you can attend the Trip of Cancun, so do not miss in any month.
- **7.** Two charts for the competition: There are 2 charts of goals, and it depends on how you have closed in the month of September 2019 is the chart that will correspond to you.
  - **a**. Chart 1: It is for those who have closed as Advisors or Coordinators.
    - **b.** Chart 2: It is for those who closed as Supervisor or higher ranks.
- **8.** Brand Partners: Distributors in this category will have goals set on a personalized basis and the Country Director will contact you to stipulate these goals.

## **TRACK YOUR PROGRESS:**

- Once you sign up for the trip, you'll start receiving messages with your goals, progress, and details. Plus, you can see for yourself how many Trip Points you have from your Back Office.
- In your Back Office you will be able to see a list with telephone numbers of the people you have enrolled and who have not yet made their personal purchases. Call them to help them achieve their Trip Points goals.
- Month by month the list of trip winners will be published. Stay tuned to our social networks and your WhatsApp group chat.

## **SPECIAL CONDITIONS FOR THE TRIP:**

- **1.** Current legal documents: In case you need Passport and/or Visa to enter and return to your country, these must be valid. Any charge needed to obtain or update these documents is the responsibility of the Distributor.
- **2.** Air transportation to Cancun: Air transportation is the responsibility of each Distributor. The airport of arrival is recommended to be the international airport of the city of Cancun (CUN). ArdyssLife will coordinate the transportation of the Distributors from the airport to the hotel and from the hotel to the airport. Previous report of the itinerary of the visitors is required to optimize the transportation.
- **3.** Lodging: The cost of rooms and food within the facilities are 100% included. Hotel rooms will be shared with another Distributor. You also have the possibility to take a guest with you and get your own room if you achieve the goals described in the chart at the end of this document.
- 4. Expenses outside the program: All expenses of the Distributor that are not considered as included in these bases, will be responsibility of the Distributor, such as transportation from the hotel to shopping or entertainment centers, telephone calls, medical expenses, payment for flight or lost connections, tours, tickets to shows, consumption in the mini bar, room service charges, Pay per view TV channels, accommodation for modifications of air or land, among others.
- **5.** Non-transferable trip: If the Distributor cannot make the trip, it cannot be transferred to another Distributor or guest.
- **6.** Non-Refundable Trip: If a Distributor is unable to make the trip, there will be no refund or economic compensation for this concept.
- **7.** Misbehavior: Any evidence of manipulation of points, modification of data or documents or irregular practices in order to qualify the trip, will be automatically disqualified, without the possibility of reconsideration and without any responsibility for ArdyssLife. ArdyssLife has the faculty and reserves the right to modify discretionary and without previous notice, the present rules in all its terms, including the requirements, as well as to cancel the present trip.

According to the rank you qualified with in September 2019, you must meet the goals in Trip Points month to attend the trip to Cancún.
